# Minutes: Annual General Meeting 2008

- 1.0 Call to order at 5:15 p.m on Thursday, Jan 31st 2008
- 2.0 President Catherine Dowd welcomed those present, recognizing that there were 32 people in attendance.
- 3.0 It was established that there was a quorum for the voting that would be taking place.
- 4.0 Moved by Joyce Cunningham, seconded by Margaret McLean, that the agenda be approved as circulated. Carried.
- 5.0 Moved by Margaret McLean, seconded by Andrew Porteous, that the minutes of the 2007 Annual General Meeting be approved as circulated. Carried.
- 6.0 There was no business arising from the 2007 AGM meeting.
- 7.0 President Catherine Dowd gave her report, thanking departing member Bob Ernest, representing Central West, for his dedication to OLBA, and in particular his work on Inside OLBA, and to Doreen Horbach, departing Past President. Cathy then extended a welcome to the newest members of Council, Jane Hilton. representing Central Eastern Region, and Marilyn Stewart, representing Northeastern Region. Other highlights of the report included the history of Cut to the Chase, our very successful tool for trustees, and announcement of the launch of the second phase of the Leadership by Design project, One Place to Look. The full text of her report is posted on the OLBA website.
- 8.0 Treasurer Margaret Wicklum gave her report, indicating that we again appear to have ended our fiscal year well within our budget. The budget for 2008 will be presented to OLA shortly, so has not yet been approved. The \$2000

we had budgeted for sharing a booth with FOPL at the AMO conference in Ottawa in August was diverted to subsidize attendance at SuperConference for one trustee from the Northwest and one from the Northeast, chosen by lottery. We await news of our share of a Trillium grant to continue with further phases of our Leadership by Design project.

Moved by Andrew Porteous, seconded by Claudette Robertson, that the Treasurer's report be accepted as presented. Carried.

- 9.0 The individual councillors' reports were included in the overall President's Report this year.
- 10.0 Jan Harder, from the Ottawa
  Public Library, asked for trustee
  support in her library's bid to
  lobby the Ministry of Culture for
  an increase in funding to libraries, which have been flat-lined
  for over 10 years. Jan will assist Quentin Esrick as OLBA
  conference organizer for Super
  Conference 2009.
- 10.01 Don Hamilton, from the Greater Victoria Public Library Board, representing the Canadian Library Trustees Association, asked for communication from trustees to develop national level participation in CLTA initiatives.
- 10.02 Don commended OLBA for our "brilliant" *Cut to the Chase*, and explained the difference between British Columbia Library Boards' Association and OLBA. In BC, BCLBA is government supported, and therefore all library boards are automatically members, unlike OLBA, which is a paid membership organization. However, he stressed that our goals are the same.
- 10.03 Joyce Smith was chosen as Trustee of the Year, and will receive her award at the Awards Dinner this evening.

- 11.0 Doreen Horbach was nominated by Jan Harder, seconded by Janie Fischbucher of New Tecumseth Public Library as the OLBA representative for Central West, replacing Bob Ernest, whose term is up. There being no other nominations, Doreen was acclaimed.
- 11.01 Margaret Wicklum was acclaimed as incoming Vice
  President, leaving a vacancy in the Eastern Region.
- 12.0 Incoming President Lynn
  Humfress-Trute spoke to the
  meeting, thanking all those
  who had worked with her last
  year, especially outgoing Past
  President Cathy Dowd.. She
  encouraged all trustees to
  communicate with OLBA, using it as a resource for better
  library governance, and stated
  her intent to work on getting
  information out to all library
  boards.
- 13.0 Moved by Marilyn Stewart, that the meeting be adjourned.

# 2008 Treasurer's Report

#### ... Jane Hilton, OLBA Treasurer

The 2008 audited report is not yet available, however OLBA exceeded its allocated 2008 budget of \$22,900.00 as a result of higher than anticipated costs of board meetings and board approved initiatives throughout the year.

At the end of December, we had spent an estimated \$28,530.00 for an over expenditure in the region of \$3,600.00.

The initiatives, which have served the membership well, included travel subsidies to the Ontario Library Association conference held in Toronto, for board members from the Northeast and Northwest region which were not budgeted for. As well, some very suc-

cessful outreach initiatives were carried out in 2008. OLBA councillors SOLS trustee council meetings showcased OLBA and the President attended and represented OLBA at the OLS-N conference. In the previous year, travel costs were lower since there were a number of OLBA councillor vacancies which have now been filled.

OLBA has upgraded it's website to accommodate the new elements of the Leadership by Design program, in particular the respected and valued online reference library – One Place to Look.

A change in the catering arrange-

ments were necessary due to the relocation of OLA offices resulting in a higher than anticipated cost for the catering services for the OLBA meetings.

Printing costs for *InsideOLBA* were also higher than budgeted since publication costs increased for the three issues produced in 2008.

The budget for 2009 has been presented to the OLA but has not year been approved.

# Leadership By Design

The Leadership by Design project ended the year under the estimated budget of \$44,000. In March 2008, the Ontario Library Association received an Ontario Trillium Foundation (OTF) province-wide grant of \$31,000 to help fund a research project and further develop the OLBA's Leadership by Design program.

The project was completed between April and December 2008 and OLA has submitted its final project report to OTF.

## Organizational Development Committee

In 2008, the Organizational Development Review Committee further refined the Terms of Reference to review organizational processes and to focus on issues of membership.

#### **Toronto representation**

The OLBA has had longstanding difficulties obtaining representation for the Toronto region on the OLBA council. The Organization Development Review Committee developed different options for Council to consider with a recommendation to address this deficiency. It was decided that until there is a Toronto representative who can serve on council, the councillor for the Mid Central region will act as a liaison between OLBA and the Toronto Public Library.

#### **Membership Model**

The Committee examined the types of membership available for Board members and the process for renewal. These included individual personal memberships as well as the present model of a block/board membership. In the end, Council opted to maintain the present board type membership but to consider more effective mechanisms to increase the communication between OLBA and board members.

The OLBA membership brochure and form was revised so that it might serve as a more effective marketing tool.

#### **OLBA Members**

A revised list of library boards with OBLA membership was compiled, including reviewing the renewal process as a preliminary step towards improving the 34% rate of membership. In addition, the OLBA activities of providing a listserve, publishing the 'InsideOLBA', awarding outstanding board members, developing Super Conference sessions and initiating the Leadership by Design program were scrutinized for determining whether they met memberships' needs. While a formal evaluation has not been completed, there are plans to review what's available in an ongoing effort to provide board members with the support they need to be effective board members.
