### President's Message 2012

In 2012 the Ontario Library Boards' Association continued to pursue its mission to be the recognized centre of excellence governance for public library boards. Some of that recognition came in the request from the Provincial Library and Literacy Office, Province of Saskatchewan for permission to adapt *Cut to the Chase* for their use.

In keeping with OLBA's vision to be a leader and recognized authority in public library governance and leadership development, two projects with Andrewes-Loucks have renewed and invigorated *Leadership by Design*.

The first project revised and updated *Cut to the Chase*, to reflect changes to the *Public Libraries Act, R.S.O. 1990, cP44*, which have come into effect since the initial publication of the document five years ago. *One Place to Look* was also realigned with those changes, updated and enhanced.

The second project focussed on the *Leadership Development Toolkit*. This element is a three-part exercise designed to help Public Library Boards identify their governance and leadership knowledge gaps, assisting boards to design board training and development programmes. The revised package offers updated survey tools, and applications streamline access and completion of the seven gaps analysis sheets and collating results all in one sleek and user-friendly module!

The OLA Executive Director, Shelagh Paterson, ABO-Franco, OLS-N and SOLS encouraged and assisted OLBA in producing a French translation of *Cut to the Chase*. Both *Cut to the Chase* and *Le vif du sujet* are available online and through the OLA bookstore.

Joyce Cunningham and Irene Moore revised the OLBA Councillors' Handbook which now contains links to all the relevant pages on the OLA website ensuring currency.

The Education Institute drew the highest board registration ever for its series **Building Better Boards: a** four part series to improve library board effectiveness.

On behalf of the OLBA, I participated on the Provincial Library Awards Panel; the OLA By-Law Committee with Joyce Cunningham, with the revision to By-Law 1 having been presented and passed at the OLA AGM in June; the OLA Board with Kim Vares.

OLBA engaged public library board members in conversation and training opportunities through the SOLS Trustees Council meetings and at the OLS-N Conference where 3 sessions were presented by OLBA Board Members. The Marketing Committee provided several messages for these events and also for the web page highlighting that memberships allow OLBA to continue to develop materials and programmes related to board issues.

The OPLA/OLBA Partnership continued at a joint meeting in September with two guests presenting. Bessie Sullivan, OLA Advocacy Committee introduced the work of the committee and asked for some preliminary feedback and for contacts to be established.

Bill Irwin, Associate Professor, Western University outlined a research proposal being presented to OLA to qualitatively evaluate the impact of public libraries on society and culture, beyond the statistics books on the shelves and people through the doors.

The article exchange between OPLA and OLBA publications was very successful and the consensus was to continue. Additionally, a joint OLBA/OPLA forum was established in the OLA Community. You will find full

The Editorial team did an excellent job this year, producing *InsideOLBA* taking it in stride with the transfer from print to the new electronic format. The fall issue was particularly informative and expanded in its concept.

Five bursary winners attended Super Conference 2012 and based on the recommendations of the Bursary Committee, Council was agreeable to extending those bursaries to first-time board members again for Super Conference 2013.

Kim Vares assumed the OLBA Presidency on Jan. 1, 2013. Kim has been a valued member of OLBA Council and has compiled an outstanding field of presenters and topics for the upcoming Super Conference. Kim serves as Chair of the Dryden Public Library and has many valuable administrative and managerial skills that will see her lead OLBA successfully in 2013.

We say good-bye to Sheila Taylor, Mid-Central representative and thank her for her participation on the Board. Lisa Csele, of Oakville Public Library Board was elected as Mid-Central representative, with Don Carter (Northeastern representative) and Pierre Mercier (Eastern Region representative) returning to Council through 2015. Don Lynch succeeds Kim Vares as Vice President/President-Elect. An interim election to fill his post as representative for Central West Region through 2013 will soon be announced.

Joyce Cunningham also leaves the Board this year following many years of dedicated service, insight and determined leadership, first as Northwestern Representative, then Vice-President, President and Past President. She has contributed enormously and leaves an immeasurable impact and awareness of the OLBA on the library community. 'Thank-you' is just not enough.

At the close of the year, a letter from the President was sent out announcing the release of **Le vif du sujet**, accompanied by a complimentary copy of **Cut to the Chase** (2nd edition); a coupon for a second copy redeemable at the OLA Bookstore during Super Conference and a chart showing all sessions relevant to library board matters.

This year has proven that once again, the dedication of volunteers is without limit. Each member of the OLBA Council not only volunteers on their local public library board, but further expands on that dedication by contributing countless hours to OLBA. Committees, portfolios and ad hoc opportunities never go begging for someone to take the lead and move things ahead.

You would need to travel far, to find a better informed and enthusiastic group whose sole objective is the Advancement of public libraries. The level of expertise and spirit of collaboration is nothing short of superb! I thank you for the opportunity afforded me to serve as your President for 2012 and in turn thank Those who worked so tirelessly on our behalf.

### Web Master's Report Frances Ryan

OLBA was able to make good use of the options provided by the new iMIS used to operate the OLA website. Bulletins announcing elections, bursary draws, promotions and events were accommodated with ease and appeared on both the OLBA web page and in the scrolling news on the OLA home page.

OLA office staff has assumed the technical side of the Webmaster position.

It was agreed that the OLBA secretary will prepare and format any written text and submit it to the assigned OLA staff for uploading to the identified location or page link. The secretary will proof the content prior to, and after posting to the site.

Given the wide variance of systems, hook-ups, software and skill levels of the assigned webmaster, and attempting to troubleshoot by telephone, this new option has been more time-efficient for OLA. OLBA benefits with consistent and timely postings and updates.



# Incoming President's Message Kim Vares

These are challenging times for libraries and library boards. The historical, ever-lasting, always-going-to-be-there services of our libraries have been threatened by fiscal pressures and restraints that have lead to reductions in programmes, staffing, hours of service and in some situations, closures.

So volunteering as a Board Member for a Public Library requires a dedication and focus unrivalled.
